**Subject: Uploading Master and Claim data in PAiSA portal for MIS cases-reg**

Dear Sir,

The Ministry of Housing & Urban Affairs have launched, in November 2018, the Portal for Affordable Credit and Interest Subvention Access (PAiSA), in collaboration with Allahabad bank for online crediting of interest subvention directly to beneficiary's account on monthly basis under the Self Employment Programme (SEP) component of DAY-NULM. During the video conference held on January 22, 2019 for review of the working of portal, States and Banks were instructed to upload master of only those NULM beneficiaries who are entered in MIS. States were also asked to upload 'Master data not uploaded' (basic detail of NULM beneficiaries) through "Unclaimed Section" on PAiSA portal.


2. Now, integration between MIS and PAiSA portal has been completed and it has been decided that henceforth:

- All Scheduled Commercial Banks and RRBs (on-boarded on PAiSA portal) should upload master for the cases available in DAY-NULM MIS only. Report of such cases can be accessed from **bank login in 'PAiSA-MIS Integration'** section of the portal.
- Instructions have already been issued to States/ULBs to update MIS on regular intervals and ensure entry of remaining and new SEP cases in MIS on priority basis. Post integration of MIS and PAiSA portal, it is not required now to upload any file/data under "Unclaimed section" of the PAiSA portal. The nodal bank (Allahabad Bank) is requested to deactivate this facility on PAiSA portal w.e.f. 1<sup>st</sup> July 2019.

3. Team from the Ministry and nodal bank will always be available to extend all necessary cooperation in this regard to make the working of PAiSA portal smooth. In case of
